He referenced complaint about his tone at February 2018 meeting and credited to the need for more commitment from the COAA. He announced that there were some open seats for commissioners, and along with Deputy Kignaman stressed the required qualifications, and need for candidates from countries not currently represented on the COAA; He announced the departure of Community Outreach Specialist Bezawit Mane, and promotion of Aly Kaba, Language Access Coordinator to Mane's role; and Vacant position for Language Access Coordinator. Upcoming MOAA and other events: Marvin Gaye Day; MOAA Know Your Rights Town Hall, tentatively scheduled for May 10, 2018, which Interim Vice Chair Kamara has agreed to moderate and Commission is encouraged to attend and partake in. 	
Chair Announcements	 Moderate and Commission is encouraged to attend and partake in. Chair Nylander echoed Director Samba in thanking the Commissioners for their in person and written testimonies at the budget and performance hearings. She extended a special thank you to Emira Woods for her guidance and assistance with helping Commissioners with their testimonies. Woods suggested that the COAA take their testimonies a step further and submit an opinion editorial to the Washington Post on the significance of representation on matters such as immigration, census, and citizenship. Loko (Eric.loko@dc.gov) presented on their work with the OAA in ensuring they maintain relationship with the African and Islamic community through various ways. 1. Every other Tuesday Ride Along initiative to build community with public and law enforcements, 12:30 PM - 2:00 PM; 2. Johnson has a 30-day rotation and introduction of new officers to the community- African officers are introduced to OAA during this period; 3. African officers help with better understanding of cultures, customs, but safety for individual's welfare is not compromised; 4. Officers have found a workaround with addressing the issues of medical costs and immigration when residents are involved in situation in which they may need medical assistance; they inform them up front that it is cost-free and that as law enforcement officers they do not tackle immigration issues; and 5.
